**RE: Approval of proposed parking, staging area, and boat launch ramp  
PR 313 (north right of way) in SW 22-15-12E  
in the RM of Lac du Bonnet**

This is in response to the request and revised plans (see attached) our office received from Kyle Dewald of your office requesting permission on behalf of the RM to construct a parking area, staging area and boat launch ramp within the right of way of PR 313 at the above location.

Our Department has reviewed the proposal and is prepared to allow the parking area, staging area and boat launch ramp (known as the 'works') to be constructed as shown on the attached drawings subject to the following conditions:

1. The RM of Lac du Bonnet shall contact our Maintenance Superintendent (Kelvin Harder, in Winnipeg at 204-268-5236) a minimum of 48 hours prior to commencing construction of the trail and to discuss proper signing, safety and miscellaneous concerns. Signing will be done in accordance with the Department's Work Zone Traffic Control Manual which can be found on our website (<http://www.gov.mb.ca/mit/contracts/workzone.html>);
2. The RM of Lac du Bonnet shall provide Mr. Harder with a list of several contacts, available on a 24 hour basis during the duration of your project, who will be assigned to respond immediately in the event of an emergency or address site safety conditions;
3. The RM of Lac du Bonnet shall be responsible for all utility location/re-location and protection, and shall be liable for damage caused to utilities located at this site;
4. The RM of Lac du Bonnet shall receive approval from the Department prior to making any changes to approved plans/ alignments;
5. The RM of Lac du Bonnet shall apply for an access permit for the proposed access relocation. The application can be made online at: <https://forms.gov.mb.ca/highway-permits-application/index.html>
6. The RM of Lac du Bonnet shall ensure that all excavation areas within highway rights-of-way are restored to their original condition (i.e. seeded) and shall be responsible for maintaining restored rights-of-way for a period of two years from the date of construction of the parking area;
7. The RM of Lac du Bonnet shall adhere to the attached "General Environment Requirements for Manitoba Infrastructure" (see Appendix A)
8. When reseeded the disturbed areas the RM of Lac du Bonnet shall follow sections 19 and 20 under revegetation of the General Environmental Requirements for Manitoba Infrastructure (see Appendix A)
9. The RM of Lac du Bonnet shall ensure that the 'works' don't impede drainage;

10. The RM of Lac du Bonnet shall be responsible for liability for all claims arising from installation, maintenance or use of the 'works';
11. The RM of Lac du Bonnet shall be responsible for the ongoing maintenance of the 'works';
12. The RM of Lac du Bonnet is subject to any restrictions and/or regulations imposed by any other Government body (i.e. Manitoba Environment, DFO, etc.) and this approval does not relieve the applicant from having to comply with their requirements;
13. The RM of Lac du Bonnet shall be responsible to remove, replace or relocate the 'works' at their expense, if required, to accommodate any future upgrading of PR 313;
14. The RM of Lac du Bonnet will be required to maintain a \$5 million (minimum) public liability insurance coverage naming the Department of Infrastructure as additional insured and shall maintain said coverage for so long as these parking areas remain in place;

Permission comes into effect when the Department receives a signed copy of this letter agreeing to all the conditions contained or implied in this letter.
