#### The Rural Municipality of Lac du Bonnet By-Law No. 02-12

Being a By-Law of the Rural Municipality of Lac du Bonnet to establish fees payable to the RM of Lac du Bonnet for municipal services rendered under the authority of The Municipal Act, The Planning Act and the by-laws of the municipality known as the Fees and Charges Bylaw.

WHEREAS subsection 232(2) (d) of the Municipal Act, provides in part as follows:

"Without limiting the generality of subsection (1), a council may in a bylaw passed under this Division

(d) establish fees or other charges for services, activities or things provided or done by the municipality or for the use of property under the ownership, direction, management or control of the municipality;

AND WHEREAS the Council of the Rural Municipality of Lac du Bonnet deems it necessary and desirable and in the best interest of the municipality to prescribe fees and charges payable to the municipality for certain services under the Municipal Act rendered by officers and employees of the municipality;

THEREFORE BE IT RESOLVED that the council of The Rural Municipality of Lac du Bonnet, in open meeting assembled, enacts as follows:

- 1. THAT this by-law shall be known as the Fees and Charges By-law.
- 2. THAT the fees and charges payable to the Rural Municipality of Lac du Bonnet for services rendered by officers and employees of the municipality shall be as set out in Schedule "A".
- 3. THAT Council from time to time, by resolution, may amend the schedule attached to this by-law.
- 4. THAT the fees and charges set out in the schedule attached to this by-law shall take precedence over any other by-law.
- 5. THAT any unpaid fees or charges owed to the Rural Municipality of Lac du Bonnet by any tax payer including any penalties related thereto as well as any fines imposed on the taxpayer may be added to the taxes of the said tax payer and may be collected or enforced in the same manner as a tax as defined by the Municipal Act.

6. THAT this by-law shall come into force and effect from the date of final passage thereof.
